Guidelines for Preventing the Spread of COVID-19

22 June 2021

Introduction

At ICC Kyoto, we have implemented a thorough set of measures to prevent the spread of COVID-19 and provide an environment where visitors can attend meetings safely and with peace of mind. These guidelines describe the practical measures ICC Kyoto implements as well as the procedures we ask organizers to follow. They were created for the purpose of better coordination, cooperation and visitor safety.

On drafting the guidelines, we referenced the "Basic Policies for Novel Coronavirus Disease Control" (March 28, 2020 / revised May 25, 2020) issued by the Japanese government and other guidelines independently issued by other industries and groups including the theater and tradeshow industries.

Because the situation is constantly changing, we will continue to monitor policy changes or new requests from the Japanese government and local authorities, as well as the social state of affairs, and make revisions to the guidelines as necessary.

1. Our treatments

<1> Admission restrictions on people suspected of having COVID-19 (fever, etc.)

Anyone who is suspected of having COVID-19 (for example, has a fever of 37.5°C or higher or other symptoms) will be refused admission to the facilities.

<2> Masks

We ask that everyone wear a mask within the facilities to help prevent the spread of the virus. However, people who cannot wear a mask due to hyperesthesia or other medical reasons are exempt.

<3> Other measures

(1) Sanitizer stations

Sanitizer stations are set up at the entrance of the Main Building, Event Hall, New Hall and Annex Hall. If additional hand sanitization stations are needed for other spaces, event organizers need to prepare them.

(2) Air circulation

Fresh air is ensured by the constant operation of air conditioning and ventilation systems in all buildings.

(3) Cleaning

High touch points including door handles and elevator buttons are cleaned, with alcohol, every morning.

To help prevent infection, cleaning staff will also wear masks and gloves. Furthermore, masks used by participants should not be disposed of within the venue or facilities

(4) Public spaces

Sofas and tables in lobby areas are arranged to encourage social distancing.

(5) Plastic sheets

Plastic sheets are installed at the main entrance information desk, the permanent cloak desk and the service entrance desk.

(6) Signage

There is signage to support health and safety messaging for the prevention of COVID-19. COVID-19 safe behavior, social distancing requirements, wearing a mask, etc.

Signboards with the QR code for registration onto Kyoto City's tracking service to help stop the spread of COVID-19, "Kyoto City Notification Service of COVID-19 Positive Cases".

(7) ICC Kyoto employees and business partner workers

- A: All employees and workers are required to take their temperature before coming to work and to wear a mask in the facilities. ICC Kyoto centrally manages the health and physical condition of all employees.
- B: Workers with a fever of 37.5°C or higher or who do not feel well must stay home.
- C: Employees and workers regularly wash hands and gargle.

2. Organizers' Obligations



ICC Kyoto has established the following admission restrictions for use of our facilities. Please comply with these rules

[A] Establish a COVID-19 Response Manager and hold preliminary meetings

In order to provide a safe and secure environment for all visitors, please appoint a COVID-19 Response Manager among your staff. The COVID-19 Response Manager will discuss and exchange information with our staff in advance regarding measures for preventing the spread of the virus.

[B] Notify the below conditions prior to the event

The organizer should notify attendees of the below conditions prior to the event and refuse admission to anyone who is suspected of having COVID-19

- 1) Anyone with a temperature of 37.5°C or higher
- 2) Anyone who has cough, sore throat, or shortness of breath
- 3) Anyone who feels fatigue or loss of taste or smell
- 4) Anyone travelling from overseas within 14 days categorized as denied permission to enter Japan or someone who has been in close contact with them
- 5) Anyone who has taken medicine or got a medical check-up at the hospital within 14 days because of common cold, or someone who has been in close contact with them
- 6) Aside from above, anyone who is suspected having coronavirus infection

[C] Check the physical condition of attendees upon admission

The organizer must conduct the following:

- ① Notify attendees of the conditions as listed above in [B], and request people to voluntarily report if any conditions apply. Notify in advance that anyone who is suspected of having COVID-19 cannot enter the facilities.
- ②Measure body temperature, etc., at the time of admission and check for symptoms as listed above in [B] (\times)
- ③ During the event, if the organizer becomes aware that someone in the facilities falls under one of the conditions as listed above in [B] or is otherwise suspected of having COVID-19, immediately have the person leave the facilities and encourage the person to go home or be examined.
- 4 Do not allow work by staff under the conditions as listed above in [B]
- * For information regarding the thermal camera used at the event, we will introduce suppliers.

2. Organizers' Obligations



[D] Exceptions to admission restrictions

As an exception, admission is allowed if there are special circumstances which significantly affect the life or rights of participants; for example, taking entrance examinations, etc. However, the organizer should take the utmost measures to prevent the spread of infection; for example, avoiding contact with other participants by setting up separate rooms for examinees who have a fever.

[E] Masks

To help prevent the spread of the virus, attendees and staff members must wear masks while inside the facilities. However, people who cannot wear a mask due to hyperesthesia or other medical reasons are exempt.

[F] Measures for singing or speaking in loud voices

If a performer will be singing or speaking in a loud voice, please make sure the performer is a safe distance away from the audience (at least 2 meters). If more than one person will be singing together (a choir, etc.), please take necessary precautions to prevent the spread of the virus. For example, mandate mask-wearing or install acrylic barriers between the performers.

In addition, staff members should be ready and in position to directly caution anyone in the audience who is speaking too loudly (cheering, etc.).

[G] When someone is suspected of having COVID-19

If anyone in the facilities is suspected of having COVID-19, immediately have the person leave the facilities, encourage an outpatient examination, and immediately inform ICC Kyoto of the situation.

If the person is not feeling well enough to leave the facilities, temporarily transport them to the first-aid room, confirm their condition, and make an immediate request for emergency transportation.

In this case also, immediately inform ICC Kyoto.

If the organizer does not comply with the above guidelines, ICC Kyoto may demand the necessary corrections to be made. In the case of damages incurred, whether intentional or due to serious negligence, ICC Kyoto may demand payment to cover actual costs (cost of disinfection, etc.).

3. ICC Kyoto's request for Organizers



[A] Admission restrictions to facilities and buildings, capacity restrictions, layout

1 - Participant capacity restrictions

For the various kinds of lecture and speaking sessions, ceremonies, exhibits, etc., ICC Kyoto is currently allowing maximum entrance for at or under 5,000 participants and at or under 50% of the standard participant capacity, with the understanding that thorough measures will be implemented to prevent spread of the virus.

2 - Event time

Events are allowed up to 21:00

Avoid the Three Cs (Crowded places, Close-contact settings, Confined and enclosed space)

Consider the risk of infection among participants and implement social distancing for the meeting room layout, reception area, cloakrooms, and other facilities in order to prevent the Three Cs. To assist in achieving this goal, please implement the following measures to the greatest extent possible.

- 1) Set the admission restrictions
- 2) Keep silent as much as possible
- 3) Limit the conference hours
- 4) Separate the entrance and exit

Furthermore, to maintain physical distance between people, we ask organizers to consider:

- Seating allocation that maintains the appropriate spacing
- Maintaining spacing between speakers, etc. and participants (2 meters minimum) and using plastic barriers
- Preventing droplet infection to adjacent seats, etc., through measures including mask wearing

[B] Establish a system for tracing participants

Please take the following measures in order to prevent the spread of infection.

- ①Make the list of participants. In case that participants who are infected attended the meeting, organizers will have to provide that list to the healthcare agency.

3. ICC Kyoto's request for Organizers



[C] Always wear masks and use proper coughing etiquette

In order to prevent the spread of infection, always wear a mask inside of facilities, use proper coughing etiquette, periodically wash your hands and gargle, and use hand sanitizer.

[D] Measures for preventing the spread of infection / raising awareness for measures

In order to prevent the spread of infection among participants, organizers should inform (including posting information on websites, etc.) participants of the following measures in advance.

- 1) ICC Kyoto's entering restrictions (see 2. Organizers' Obligations)
- 2) Participants should measure their body temperature before leaving home
- 3) Participants wear masks and mind the "coughing etiquette"
- 4) Participants wash hands and gargle before leaving home
- 5) Participants use sanitizers before entering the venue
- 6) Participants should refrain from discarding masks in the venue



4. Food and Beverages

Food and beverage policies will be as below until further notice.

(1) Serving style

We encourage serving food in courses or in bento lunchboxes, which have a relatively low risk of spreading the virus. Buffet style serving will only be allowed with seating in Banquet Halls Sakura and Swan, and only if social distancing measures are implemented.

(2) Prevention of droplet transmission

- A. Always wear a mask when not consuming food or beverages.
- B. We advise maintaining sufficient spacing through measures including leaving
 - 1 seat open to the front and back, and to the left and right.
 - If the layout does not allow a minimum of 2 meters spacing between people, always install plastic barriers at seats.
 - Also, when alcohol is present, always install plastic barriers at seats regardless of the layout.
 - In addition, even if alcohol is not present or if food and beverage consumption is simple as in the case of meal sets, we recommend restricting seats facing each other and installing plastic barriers.
- (3) If changes arise for food and beverage consumption, such as consumption time, due to requests from the national or local government, ICC Kyoto will comply with and enforce those changes.
